DURING FISCAL YEAR 2021, THE JUNGLE THEATER WAS UNABLE TO PRESENT A TRADITIONAL SEASON OF FIVE TO SIX PLAYS, DUE TO THE COVID-19 PANDEMIC. HOWEVER, THE THEATER WAS COMMITTED TO TWO GOALS: FINDING TEMPORARY ALTERNATIVE PROGRAMMING OPPORTUNITIES TO MAINTAIN CONNECTIONS TO ARTISTS AND AUDIENCES, AND TO MAINTAINING THE INTEGRITY OF THE ADMINISTRATIVE OPERATIONS AND FACILITY TO ALLOW FOR AN EFFICIENT RETURN TO REGULAR PROGRAMMING WHENEVER POSSIBLE. THE COMBINED RESULT OF THESE GOALS LED TO A YEAR WHEN THE PERCENT OF EXPENSES SPENT ON PROGRAM COSTS WAS UNUSUALLY LOW (61.4% IN FY2021 COMPARED TO 77.8% IN FY2020). WITH A RETURN TO REGULAR PRODUCTIONS PLANNED IN FY2022, WE EXPECT A RETURN TO HISTORIC EXPENSE BALANCES.

OTHER ACTIVITIES
IN 2021, WE LAUNCHED A NEW, INCLUSIVE ARTISTIC COHORT WHO HAVE A SEAT AT THE TABLE UNDER THE LEADERSHIP OF OUR ARTISTIC DIRECTOR IN MAKING ALL ARTISTIC DECISIONS, INCLUDING SEASON PROGRAMMING. THIS FIRST COHORT OF FOUR ARTISTS ARE PAID, QUARTER-TIME EMPLOYEES (TEN HOURS PER WEEK) WHO ALSO RECEIVE FINANCIAL AND PRODUCTION RESOURCES TO SUPPORT THEIR INDEPENDENT PROJECTS, SOME OF WHICH MAY BE PRESENTED ON THE JUNGLE'S STAGE. THEY REPRESENT A RANGE OF BACKGROUNDS AND EXPERIENCES WITH UNIQUE PERSPECTIVES AND COMPLEMENTARY PERSONALITIES.
